

Brief Background



Population of Scheduled Tribes (STs) as per Census 2011 is **10.45 crore**, which is **8.6% of the country's population**.

Tribal Sub Plan (TSP) / Scheduled Tribe Component (STC) / Development Action Plan for Scheduled Tribes (DAPST) strategy adopted to ensure comprehensive development for the ST community.

DAPST funds are dedicated source of financial resources for the development of tribal people across the country.



42 Central Ministries/ Departments are working for the welfare and socio-economic development of Scheduled Tribes under the umbrella of DAPST.

The entire budgetary allocation of Ministry of Tribal Affairs comes under the ambit of DAPST as the Ministry is primarily mandated for welfare of tribal communities.

Over 200 schemes relating to literacy, health, skill development, education, livelihood, agriculture, sanitation are encompassed under DAPST.

Allocation under DAPST has seen an over **5-fold increase** from **Rs. 21,525.36 Crore** in 2013-14 to **Rs. 1,17,943.73 Crore** in 2023-24.

Jal Jeevan Mission- Har Ghar Jal

Department of Drinking Water and Sanitation



- Government of India launched the Jal Jeevan Mission i.e., Har Ghar Nal Se Jal to provide all households in rural India with safe and adequate drinking water through individual household tap connections.
- Government has allocated **Rs 19101.17 crores since 2019-20 for the ST people**, by providing household tap water supply.
- The mission lays focus on community participation and promote Gram Swaraj by giving power to the village people, as construction work of a village water supply scheme is taken up as per demand and needs of the local community.
- By providing safely managed drinking water to all of India, **around 4,00,000 diarrhoeal disease deaths** are estimated to be averted across the country.
- **More than 1.40 Crore rural households** have been provided tap water connection in ST concentrated areas.

Swachh Bharat Mission (Rural)

Department of Drinking Water and Sanitation,
Ministry of Jal Shakti



- Swachh Bharat Mission is the world's largest sanitation initiative of the Government launched by the Prime Minister of India in 2014 which aims to improve sanitation, cleanliness and to achieve an Open Defecation Free (ODF) India by **October 2, 2019**.
- The mission aims to motivate communities to adopt sustainable sanitation practices and facilities through awareness creation and health education.
- Has a provision of incentive upto **Rs.12,000/-** for construction of Individual Household Latrine (IHHL) for all the Scheduled Tribe (ST) households.
- All the villages (including Tribal areas) in the country have already declared themselves ODF.
- Government has allocated **Rs 7923.75 crores since 2014-15 to 2023-24** in this mission to construct Individual household latrines (IHHLs) for the tribal people to bring about the improvement in the general quality of life in the rural areas, by promoting cleanliness hygiene.
- **Around 1.5 crores IHHLs constructed** for STs since launch of the Mission.



PM Awas Yojana (Rural)

Department of Rural Development



- Pradhan Mantri Awas Yojana aims to provide Housing for All.
- Providing a pucca house, with basic amenities, to all houseless and such households living in kutcha and dilapidated house
- The beneficiaries are provided with the assistance of **Rs. 1.20 lakh** for plain areas and **Rs 1.30 lakh for the hilly**, difficult, and Integrated Action Plan (IAP) areas
- Beneficiaries are entitled to **90-95 days** of employment under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). Further, loan facility of up to **Rs. 70,000/-** is extended to the beneficiary.
- In the existing multi-level prioritization priority is first assigned to SC/ST based on the housing deprivation
- To cherish the dream of “Home sweet Home” Government has allocated **Rs. 41687.30 crores** for the ST beneficiaries since 2015-16.
- More than **65 lakh houses** are sanctioned for the ST community, out of which more than 54 lakh have been constructed to fulfil the aspiration of tribal people (As on 11/02/2024).
- **4.90 lakh houses** for PVTGs approved under the PM JANMAN Mission with a unit cost of house to **Rs. 2.39 lakh including** additional facilities.

National Rural Livelihood Mission (NRLM)

Department of Rural Development



- The mission aims to reduce poverty by reaching out to all the rural poor families (BPL families) and link them to sustainable livelihoods opportunities.
- Ensures that at least one member from each identified rural poor household, preferably a woman, is brought under the Self-Help Group (SHG) network in a time bound manner.
- Focus on setting up of SHGs at various levels.
- **Rs. 10,000/-** is given towards SHG formation and development.
- Capital subsidy is given to both members of SHGs and individual beneficiaries with a ceiling of **Rs 20,000 per ST individual**.
- Provision of Vulnerability Reduction Fund (VRF) up to **Rs. 1,50,000 per Village Organization (VO)**
- Impart training, capacity building, and skill building to diversify livelihood need of the poor.
- **1.25 crores ST members** are estimated to have been enrolled under SHGs.
- Stressing on adopting whole of government approach, G.O.I. has allocated **Rs. 11,968.44 crores** during 2014-15 to 2023-24 to bring all the poor tribal and marginalized ST rural households under the SHG fold.



PM Kisan Samman Nidhi (PM- KISAN)

Department of Agriculture and Farmers Welfare



- PM- KISAN scheme was launched in **February 2019**.
- To provide financial assistance to Cultivable landholding farmer families across the country.
- An amount of **Rs. 6,000 per year** is provided in 3 equal instalments to the eligible farmer families through DBT mode.
- Government has allocated **Rs. 28,995.20 crores** for STs since its launch for providing support to ST farmer families under the scheme.
- **Around 1 crore ST farmers** are being provided benefits under the scheme.



Livestock Health and Disease Control Programme

Department of Animal Husbandry and Dairying



- Aims to improve animal health through vaccination programmes against various diseases of livestock and poultry.
- Led to prevention of diseases, higher productivity from animals and improved the socio – economic status of ST livestock and poultry farmers.
- DAPST Outlay under the programme stands to be more than **Rs 533 crores during last 6 years.**



PM Poshan Shakti Nirman

Ministry of Education



- Aim is to foster nutritional understanding and education across India through a theme centered on "Suposhit Bharat, Sakshar Bharat, Sashakt Bharat".
- Provision of one mid-day meal free of charge to children studying in classes I-VIII, in all Government and Government aided schools.
- Implemented across the country and covers **12.16 crore children** of Bal Vatika (just before class I) and Classes I-VIII studying in **10.84 lakhs Government and Government-Aided Schools**.
- To encourage tribal focus education and nutrition seeking behaviour Government has earmarked more than **Rs. 11,452 crores for the ST children during the year 2014-15 to 2023-24**.
- **More than 1.5 crore ST students** get mid-day meal under the scheme.



- Scheme aims to educate all children, thereby ensuring inclusive and equitable quality education at all levels (pre-school to class XII) of school education and bridging social and gender gaps.
- Provision for new/ upgradation of schools from pre-primary to senior secondary level and strengthening of existing schools.
- Scheme reaches out to ST children with having a provision of **free textbooks to all children and free uniforms to all girls, SC, ST and BPL boys** at elementary level including primers/textbooks for tribal languages with bridging materials.
- To ensure that all ST children get quality education while taking care of their diverse background and multilingual needs, **Rs. 32,032.71 crores** funds have been earmarked exclusively for them to become active participants in the learning process.
- **More than 2.5 crore ST students** enrolled from Class 1 to Class XII.
- Literacy rate for STs has improved from 59% (Census) in 2011 to 73.6% (as per Annual Periodic Labour Force Survey (PLFS) report (July 2022 – June 2023))



National Social Assistance Programme

Ministry of Rural Development



- Provides financial assistance to the elderly, widows and persons with disabilities in the form of social pensions.
- Citizens living Below Poverty Line and 60 years or above in age are eligible to apply. A monthly pension of **Rs.200/-** is given to people upto age 79 and Rs. 500/- to persons who are 80 years and above.
- **Central assistance @ Rs.300/- per month** is provided to widows in the age group of 40-79 years and belonging to family living below poverty line. Beneficiary would be shifted to old age pension scheme for getting pension of **Rs. 500/- per month**.
- Under the scheme, **Central assistance @ Rs.300 per month** is provided to persons aged 18-79 years with severe and multiple disabilities and belonging to family living below poverty line. Beneficiary would be shifted to old age pension scheme for getting pension of **Rs. 500/- per month**.
- BPL household is entitled to a lumpsum amount of **Rs. 20000/-** on the death of the primary breadwinner aged between 18-60 years.
- To provide financial assistance to ST beneficiary government has funded **Rs. 3018.25 crores** since last 3 years.
- **Around 30 lakh ST beneficiaries** are getting benefits under NSAP.



PM Ujjwala Yojana

Ministry of Petroleum and Natural Gas



- Started in 2016 with an objective is to provide clean cooking fuel to poor households across the country.
- Under PMUY, a free LPG connection is provided to adult women from poor households.
- 75 lakh additional LPG connections to be released in 3 years from FY 2023-24, taking the total number of PMUY beneficiaries to **10.35 crores**.
- To empower ST women economically and socially with easier access to **LPG**, Government has allocated **Rs. 2532.86 crores** during the year 2019-20 to 2023-24.

Pradhan Mantri Fasal Bima Yojana (PMFBY)

Ministry of Agriculture and Farmers Welfare



- Scheme started in 2016
- To provide financial assistance to farmers suffering crop loss/damage arising out of unexpected natural calamities.
- Encourages adoption of modern agricultural practices, food security, crop diversification and development of agricultural sector besides protecting farmers from production risks.
- Government of India has allocated **Rs. 8,918.77 crores** under PMFBY for the welfare of ST farmers in last 9 years.

PM Matsya Sampada Yojana

Department of Fisheries



- **Launched in 2020**
- Aims to enhance fish production to **220 lakh metric tons** by 2024-25.
- Supports creation of post-harvest infrastructure such as fishing harbours/fish landing centers, cold storages and ice plants, fish transportation vehicles including refrigerated and insulated vehicles, ice flaking and ice crushing units, ice/fish holding boxes, etc.
- To provide financial assistance and holistic development to fish farmers from tribal communities, Government has spent **Rs. 482.73 crore** since its launch.




Mahatma Gandhi National Rural Employment Guarantee Act

Ministry of Rural Development



- Provide at least **100 days** of guaranteed wage employment in every financial year to every rural household whose adult members volunteer to do unskilled manual work.
- **About 2.40 crore STs are getting benefitted under MGNREGA.**
- The percentage of participation of Schedule Tribe (ST) out of total person-days generated is around 18% every year.
- Fund allocations under MGNREGA for ST beneficiaries over last three years have been **Rs 31,094 crores.**



Anganwadi Services

Ministry of Women and Child Development



- A nutrition support programme to address malnutrition in children, girls, pregnant women and lactating mothers
- Provides services like Immunization, Health check-up, Pre-school non-formal education, Nutrition and Health education, to all eligible beneficiaries
- Supplementary nutrition is provided in the form of Hot Cooked Meal with morning breakfast and Take-home rations at Anganwadi centers.
- To promote nutrition awareness among the tribal population and thereby contribute to holistic development of STs, an amount of **Rs. 17,313.48 crores** have been funded during 2014-15 to 2023-24.



Pradhan Mantri Matru Vandana Yojana

Ministry of Women and Child Development



- **Launched in 2017**
- A maternity programme for financial support to pregnant and lactating mothers to improve the nutrition and health for mother and child
- To promote positive behavioral change towards girl's child by providing **additional cash** incentive
- For first child, an amount of **Rs. 5000/-** is given in two instalments
- Benefit of **Rs. 6000/-** is provided subject to second child being a girl child.
- More than **Rs. 14,103 crore** disbursed to more than **3.11 crore pregnant women and lactating mothers**.
- Allocation under DAPST for the said scheme has been **more than 430 crores** since 2018.



Ayushman Bharat

PM Jan Arogya Yojana



- **Launched in 2018**
- World largest insurance scheme to provide health protection cover
- Benefits cover of **Rs. 5 lakh per family per year**
- Financial protection to 12 crore poor families including the tribal families
- Over **26 crore** Ayushman Cards issues
- Over **5.7 crore** people treated free of cost
- Active participation of **2.21 lakh** private hospital
- Ayushman Bharat Health infrastructure mission aims for creation and improvement of long-term Public Health infrastructure
- To provide deprived family health coverage and protect poor ST beneficiaries against the double-whammy of disease, government has allocated **Rs. 21,99.65 crores** during the year 2019-20 to 2023-24.



PM Kaushal Vikas Yojana

Ministry of Skill Development and Entrepreneurship



- Free skill training imparted to the youth besides incentivization through monetary rewards to youth for skill certification
- Short term training provided to candidates who are school/college dropouts or unemployed to help them earn their livelihood
- **Over 1.38 crore youth trained**
- Around 7 lakh ST beneficiaries trained and upskilled
- **32700+ centres** opened under the National Skill Development Corporation (NSDC) since 2014.
- Government has allocated **Rs. 1243.10 crores** in the last 7 years to train ST beneficiaries and equip them with necessary skills.

PM Vishwakarma Yojana

Ministry of Micro, Small &
Medium Enterprises



- Launched in 2023 with an outlay of **Rs. 13,000 crore** for a period of Five years.
- To provide financial support the people engaged in traditional crafts as well as to keep the age-old traditions and diverse heritage alive through local products, art and crafts
- Skill upgradation basic training of **5-7 days** and advanced training of 15 days or more, with a stipend of **Rs. 500 per day**
- Provision of collateral-free credit support of up to **Rs. 1 lakh** and **Rs. 2 lakh** with tenures of **18 months and 30 months**, with a concessional interest rate of 5%.
- Beneficiaries are given a toolkit incentive of **Rs. 15,000**.
- The scheme intends to reach and prosper **30 lakh families**, including tribal families.



Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)

Department of Land Resources



- **Launched during the year 2015-16**
- Aims at increasing water use efficiency at the farm level through drip and sprinkler irrigation systems
- Since 2015-16, **78 lakh hectares** covered
- Target for creation of **4.5 lakh hectare** of irrigation potential through surface minor irrigation
- Micro Irrigation Fund of **Rs. 5,000 crore** created in collaboration with NABARD
- More than **58 lakh farmers** including ST farmers benefitted.
- **Rs. 93,068 crore** allocated for PM Krishi Sinchayee Yojana for 2021-26
- DAPST allocation with an outlay of **Rs. 1742.04 crores** in the last ten years.



Pradhan Mantri Awas Yojana (Urban)

Ministry of Housing and Urban Affairs



- **Launched in 2015** aligned with the vision of Housing for All.
- Aims to provide all weather **Pucca Houses** to all eligible beneficiaries in the urban areas of the country.
- Central assistance for housing increased 10 times from **Rs. 0.20 lakh crore** to **Rs. 1.86 lakh crore** during the period from 2004-14 to 2015-22
- Out of **118.63 lakhs houses** sanctioned, more than 79 lakhs houses have been completed including for ST beneficiaries
- To address the housing requirement of urban tribal poor families more than **Rs. 3679 crores** have been sanctioned under PMAY-U since its launch

Farmer Producer Organizations (FPOs)

Ministry of Agriculture and Farmers Welfare



- Formation and Promotion of **10,000 Farmer** Producer Organizations (FPOs) and launched in the year 2020 with a total budgetary outlay of **Rs.6865 Crores** (till 2027-28)
- Financial assistance upto **Rs.18.00 lakh** released per FPO for a period of 3 years
- Matching equity grant upto **Rs. 2,000 per farmer member** of FPO with a limit of **Rs. 15.00 lakh per FPO**
- Facility of loan availability to FPOs up to **Rs. 2.00 crore** per FPO without collateral
- Credit guarantee cover of **Rs. 137.91 crore** issued to 703 FPOs
- To develop FPOs in produce clusters and enhance income of the ST farmers a DAPST allocation of **Rs. 185.70 Crores** has been made since 2021-22

Employees Pension Scheme

Ministry of Labour and Employment



- Employees' Pension Scheme (EPS), 1995, to provide social security
- Increase in minimum wage ceiling from **Rs. 6500/- to Rs. 15000 per month** from 2014
- Provision of a minimum pension of **Rs. 1000 per month** to the pensioners under EPS, 1995 from 2014
- Employees Provident Fund Organisation (EPFO) has credited 8.15% interest in over 24 crore accounts including ST beneficiaries.
- To provide social security coverage to the ST beneficiaries Government has allocated **Rs. 4105.86 crores** during the period 2017-18 to 2023-24.



Pradhan Mantri Garib Kalyan Ann Yojana (PMGKAY)

Department of Food and Public Distribution



- To remove the financial burden of the poor beneficiaries by providing food grains free of cost to Antyodaya Ann Yojana (AAY) households and Priority Households (PHH)
- Ensures effective and uniform implementation of National Food Security Act 2013 (ONE NATION- ONE PRICE -ONE RATION)
- Provides for coverage of upto **75% of the rural** population and upto **50% of the urban** population.
- **About 120 LMT** food grains being distributed free to 80 crore individuals, during COVID19 crisis under PMGKAY.
- Free food grains to **81.35 crore** NFSA beneficiaries for a further period of five years to be given with effect from 1st January, 2024
- During ongoing Kharif Marketing Season (KMS) 2023-24, upto 17.12.2023, a quantity of **365.48 LMT** of paddy has been procured benefiting 30,90,303 farmers with MSP value of **Rs. 80,515.26 crore**
- During Rabi Marketing Season (RMS) 2023-24, a quantity of **262.02 LMT** of wheat was procured benefiting **21,28,985 farmers** with MSP value of **Rs. 55,679.73 crore.**
- To ensure food and nutrition security for ST communities **Rs. 29,897.53 crores** allocated by the government in last three years.



Pradhan Mantri Formalisation of Micro Food Processing Enterprises

Ministry of Food Processing Industries



- Operational for a period of five years from 2020-21 to 2024-25 with an outlay of **Rs. 10,000 Crore** for supporting **2 lakh** micro food processing enterprises
- Aims to formalise the food processing sector by providing financial, technical and business support for setting up / upgradation of micro food processing enterprises in the country
- Credit-linked capital subsidy @35% of the eligible project cost - maximum of **Rs. 10.0 lakhs per unit** for upgradation or setting up of new units
- **Seed capital @ Rs. 40,000/- per member** of SHG for working capital and purchase of small tools maximum upto **4 Lakhs** per SHG.
- Providing Capacity building and training on Food Processing Entrepreneurship Development Programme to the PMFME beneficiaries
- To promote the local products, One District One Product (ODOP) approach has been adopted
- Under the credit linked subsidy component of the PMFME Scheme, **62,282 loans** have been sanctioned including **61,796 individual beneficiaries, 34 Farmers Producers Organizations (FPOs), 433 Self Help Groups (SHGs)** and 19 Producer Co-operative Societies. (As on 8 Dec 2023)
- To support ST entrepreneurs for setting up food processing enterprises government funded **Rs. 74.40 crores** during last three years.



Pre-Matric Scholarship

Ministry of Tribal Affairs



- Conceptualized with the objective of supporting parents of scheduled tribe students for education of their wards studying in classes IX and X
- Parental income not to exceed **Rs. 2.5 lakhs per annum**.
- Scholarship credited in students account directly.
- **Rs. 2935.36 crore** released since 2014-15.
- **More than 1.4 crore** All India beneficiaries of pre- matric scholarship since 2014



Post-Matric Scholarship

Ministry of Tribal Affairs



- Empowerment of Tribal through scholarship schemes
- ST students studying in all post matriculation courses (**XI to Ph.D. level**) from a recognized Institutions who have passed **X or equivalent**
- Parental income not to exceed **Rs. 2.5 lakhs per annum**
- End to End digitisation of release of scholarship
- **Rs. 16335.68 crore** released since 2014-15.
- **More than 2.33 crore** beneficiaries of post- matric scholarship since 2014



Eklavya Model Residential Schools Scheme (EMRS)

Ministry of Tribal Affairs



- **EMRS started in 1997-98** to impart quality education to ST children, carved out as a separate scheme in 2018-19
- Caters to students from **Class 6 to 12**
- Every block with **50% or more ST population** and **20,000 or more tribal persons** to have an EMRS.
- 480 students per school.
- More than **1.2 lakh students** are getting benefit.
- **740** (452 new+ 288 old) EMRS to be set up by 2026.
- Upgradation of 211 old schools **@Rs. 5 crore per school**
- Setting up of 15 CoEs in spots **@Rs. 5 crore Each**
- Recurring cost **Rs. 42,000 per student per annum** in 2014 increased to **Rs.1,09,000 per student per annum** in 2023-24.
- Unit cost of each school from **Rs. 20 crores** to **Rs. 38 crores**, and for hilly areas from **Rs. 24 crores** to **Rs. 48 crores**.
- Approval of **Rs. 28,919.72 crore** for the period 2021-22 to 2025-26.



- PMJVM has a total financial outlay of **Rs. 1612.27 crore** for implementation during the financial years 2021-22 to 2025-26
- To strengthen tribal entrepreneurship initiatives and to facilitate livelihood opportunities, optimum use of natural resources, Agri/Non-Timber Forest Produce/ Non-farm enterprises
- Structural component of Van Dhan Vikas Kendra's (VDVK) with a common facility centre for procurement cum value addition of tribal products/ produce
- Each VDVK SHG has **20** members. **15** SHGs (300 members) form a VDVK
- **Rs. 15 lakhs** Central grant provided to State Implementing Agencies through TRIFED for VDVK promotion, training and equipment
- **About 4000 VDVKs sanctioned**
